In spite of the challenges caused by the global pandemic, the recently concluded fraternal year 2019-2020, was historic and a huge success!

After three years, our jurisdiction attained the coveted Circle of Honor, with an Intake Gain of 122.03%, placing Number 2 in the entire Order, consisting of 75 jurisdictions! As an icing on the cake, IPSD Wally Streit has "earned the distinction of being the Top Recruiter in all Knights of Columbus Insurance Territories." He recruited 227 new members. As well, we were recognized for having 50 Award Winning Councils. Out of this, 14 Councils were awarded the most sought after award, the Star Council. This is in recognition for excellence in Programs, Membership, Insurance, and full compliance with required Reports, such as Form #365, Form #1728, Form SP7, and applicable safe environment requirements. The rest of our winning Councils were awarded either the Columbian Award, the McGivney Award, the Founders' Award, or a combination of these awards. Under the Insurance Awards, General Agent Marc Bouchard placed Number 3, attained 174% of Quota, with a Volume/Member of \$18,024.88 and gross volume of \$299,862,000. Field Agent Cleophas Castillo, placed Number 2, with a Volume/Member of \$29,279.82 and gross volume of \$20,613,000.

Only this time, thanks to the COVID-19 pandemic, we will be celebrating in a different environment with family and friends giving thanks to Our Lord. But still let us not forget those less fortunate than ourselves both here at home and abroad. Every day the news shows us victims suffering from some calamity, displacement, or act of violence occurring somewhere in the world. - To ensure timely processing ALL receipts must be attached to the respective expense claims when applicable. Please note that if meals are to be reimbursed, State does not cover the cost of any alcoholic beverages.
- All cheques received from the State Board are to be cashed when received. Every year, we have several cheques that become stale dated.
- Per Capita and Insurance statements are to be paid within 60 days of receipt of invoicing.
- State Scholarship cheques are sent to the Grand Knights for presentation to the winners at a public function.

Prospect Name Drive

ue to the global pandemic, the State membership recruitment process, PROSPECT NAME DRIVE, will temporarily replace the Church Drive that the Councils traditionally do to recruit members. This membership recruitment process relies more on the State Membership Team to do the recruitment efforts to assist each of the Councils and Districts to attain their quota for Columbian Year 2020-2021 and eventually the Star Council Award.

Step 1

- Each Council will provide the "Prospect Name State Pool" with names and contact information at least equivalent to the number of quotas of the specific Council for the Fraternal Year;
- Based on experience, not all the prospects are converted to membership. The State Membership Team will then monitor the number pf prospects who became a member, i.e., exemplified or emember, and will adjust the required number of prospect names per quarter until the Council intake for the quarter is met;
- District Deputy will coordinate with the Council for each quarter to track the number of names submitted to the pool and work with each of the Council to meet the member intake per quarter;
- Dan Michael will maintain the spreadsheet record of the names submitted and will provide a quarterly worksheet to the State Deputy, State Membership Director, State Online Director, New Council Development Director;

Step 2

- State Membership Director (SMD) will assign prospect names to specific members of the State Membership Teams (SMT)
- Before the assigned State Membership recruiter contacts the prospects, he will contact the Council to garner information about the Council, including activities, annual dues and how they can be paid etc.

From the Charitable Foundation

Greetings to my Brother Knights.

I trust that you and your families are well and making the best of these pandemic times.

Our investment portfolio has done quite well since my last report. The market value is now about \$ 3.1 Million and is up about \$200,000 from the March 31, 2020 market value. No additional funds have been added to the portfolio during this period.

Based on our long-term capital, the Foundation will disburse \$ 103,000 this year to charities compared to a total of \$94,700 in 2019. So far, we have disbursed \$79,000 in response to requests.

Once the lockdown due to the Covid-19 pandemic ends, we will resume visits by the Foundation Directors to Councils to ensure all Knights are aware of the Foundation and its work on their behalf.

The Covid-19 pandemic has brought a great many changes in our personal lives and in the economy. All of us have encountered changes that are unprecedented. Churches have been closed. Community recreation facilities, social groups, summer camps, and non-profit organizations of all stripes have been forced to close. Social distancing is keeping volunteers at home. Fund raising events to support charitable works have been cancelled.

There is a huge need for assistance in our communities.

The ongoing Covid-19 pandemic has intensified the need to provide support for worthy charities everywhere. In this regard, I am pleased to announce that the Foundation has developed a new partnered giving program to assist and support Councils in their mission of charity within their local community. The ACF will match at 50% to a maximum of \$500 a donation by a Council or individual that is designated for a charity. The total funds available under this pro-

As you know that the State Council have announced a new initiative called "Prospect Name **Drive**" to replace the membership Church drive temporarily. As per the notification received from Supreme, we are replacing the use of a Council based prospect landing page with new generic Knights of Columbus Canada Online Prospect Landing Page. We have improved the Online Prospect Landing page for 2020. This new form has been designed to help streamline how your Council gathers prospect information at events and church drives.

Any info about the prospect is obtained.

- State Membership recruiter then makes contact with the prospects. He will conduct an interview (explain about the order, benefits, expectations, how the prospect becomes a member), and then determine if the prospect is prepared to become a member.
- Assuming the prospect is on board, and then a form 100 is fully completed.
 The State Membership recruiter will determine if the prospect wishes to become a member via a live exemplification, an On Line Exemplification or in some cases, an e-member. In the latter case the name could be referred to the State Online Director (SOD) to quickly complete the registration.
- Once it is determined that the prospect will attend an Exemplification -- then contact is again made with the Council to ensure the name is approved and the question of the method of the payment of the dues is resolved.
- Then the State Membership Recruiter ensures the link to register is forwarded to the prospect and follows up to make sure the candidate registers and makes a reminder call prior to the scheduled exemplification.

Step 3

- The Council FS is advised by Supreme Membership Growth that the candidate has taken the exemplification.
- The State Membership recruiter then submits the completed form 100 to Supreme Membership Growth or the Council FS records the new member via Officers On Line.
- The Council is then encouraged to welcome the new member and where possible have the new member complete a Council Activity sheet, to ensure the Council gets the new member involved in the Council.
